

CAMPGROUND FEES

Windmill Hill (Wooded area) \$8.75/night/site
Point Folly (Waterfront)
 Tents \$13.00/night/site
 All other types of camping vehicles \$15.50/night/site
Visitors \$3.00/car

CAMP DAY

The camp day extends from time of arrival until twelve noon of the following day. Reservations take effect at 12 noon.

CAMPING PARTY

The campsite fee covers a camping party of four related persons. If more than four related persons wish to camp on a site, there is an additional charge. For two additional related adults the charge is the rate of the nightly fee for the site. The maximum number of persons per campsite is SIX except that a camp registrant may occupy a single campsite at the nightly fee with spouse and his or her UNMARRIED children regardless of whether or not the total exceeds four persons. Minors (under 18) are not permitted in camp unless accompanied by an adult.

CAMPING VEHICLE

Point Folly – Tent and Trailer R. V. camping are allowed. Size of camping vehicle allowed is determined on the basis of the site involved and is subject to approval of the camp manager.
Windmill Hill – No vehicle larger than a standard sized van or pickup are allowed in the campground. Restricted to tent camping.

FACILITIES

Drinking water*, pit toilets, and dumping station are provided. Not provided are INDIVIDUAL connections for electricity, water or sanitary facilities nor are there laundry units, showers, lodges or shelters on our campgrounds. A campground store and marina are operated near the entrance to Point Folly. Public boat launching facilities are available at our Marina. Campers may launch boats from our launch for a reduced charge and Point Folly campers may moor boats near their campsites.
Sandy Beach, located on Bantam Lake, is available for swimming for a nominal fee. Directions and regulations may be obtained at the Campground Store.
*WINDMILL HILL – Water is available nearby (see map).

LENGTH OF STAY

The length of stay in any campground is limited to fourteen consecutive days. Between EACH stay, regardless of duration, a seven day interim period is mandatory for ALL members of the camping party. All equipment must be removed from the campground between each camp stay.

PAYMENT

A deposit of one night's fee is required for 2-3 nights' stay; a deposit of 3 nights' fees is required for stays of 4-7 days; and a deposit of 5 nights' fees is required for stays of 8-14 days. Deposits are NOT REFUNDABLE. Make checks payable to White Memorial Foundation, Inc. a deposit is required for EACH site for EACH stay.

RESERVATIONS

Reservations are accepted by MAIL ONLY until Memorial Day weekend; after which time reservations will be accepted in person at the Campground Store. Telephone reservations are not accepted

If you wish, print out the form included with this notice and mail it along with your deposit to White Memorial Foundation, Box 368, Litchfield, Ct 06759

The minimum reservation is two days and three days on holidays weekends. A two day weekend reservation consists of Friday and Saturday nights. The maximum stay is fourteen days. If a reserved site is not occupied during the first 24 hours of the confirmed reservation by the camper who made the reservation, the reservation will be cancelled and the deposit forfeited.

Reservations should be sent to the White Memorial Foundation, Box 368, Litchfield, Ct 06759 after January 15. From January 15th until February 15th, reservations for ONLY stays of 7 days or more will be accepted.

UNRESERVED SITES

All sites not reserved in advance are on a first come, first served basis.

YOUTH GROUP TENT CAMPING

Youth group tent camping sponsored by organized non-profit organizations including, 4-H, etc., is not permitted at either Point Folly or Windmill. The Foundation maintains other areas for such groups. Information may be obtained at the MAIN OFFICE of the Foundation - (860) 567-0857
